REPORTING ENTITY.

REVIEW REPORT

Report on the Financial Statements.

I have reviewed the accompanying Financial Statements of the New Plymouth Contract Bridge Club Inc which comprises the Statement of Financial Position as at 30 September 2019 and the Statements of Financial Performance and associated Notes to the Accounts.
