

Playing the Game - Alerting

During the bidding players have an obligation to alert their opponents when their partner's bid is conventional (i.e. a non natural bid with a special meaning). Alerting is not optional and players need to know which bids in their system are alertable. The objective of the Alert system is for both pairs at the table to have equal access to all information contained in the bidding.

Important points to keep in mind:

- Bridge is not a game of secret messages; the auction belongs to everyone at the table.
- Remember that the opponents are entitled to know the agreed meaning of all calls.
- The bidding side has an obligation to disclose its agreements and understandings from partnership experience.
- When asked, the bidding side must give a full explanation of the agreement. Stating the common or popular name of the convention is not sufficient.

When opponents make an alerted or non-alertable conventional call you are entitled to ask specifically about that call at your first turn to call thereafter. But, while the Laws give you the right to ask questions, unnecessary enquiries or questions directed at particular calls may convey unauthorised information to partner. It is therefore not advisable to ask questions if your intention is to pass regardless of the answer (You have the opportunity to ask those questions at the end of the auction). If there is no partnership agreement or understanding as to the meaning of a call you must say so (eg "no partnership agreement" or "undiscussed") and not attempt to offer a possible explanation. Where there is no partnership agreement or understanding about a call do not offer statements such as: "I take it to mean...." or "I'm treating it as..." Such responses are improper as they give unauthorised information to partner.

Next month we will cover definitions of "conventional calls" and "natural calls" and give more detail of which bids should and should not be alerted.

The Danger of Partnering Your Partner

Of course there is nothing wrong with husbands and wives playing as a bridge partnership. But it usually wiser to play as opponents. Then after the game they can listen sympathetically to what each had to endure from their playing partner without blame or acrimony or condemnation being involved in the discussion!

A bridge couple had been quarrelling throughout the tournament. In the lift on the way back to their room they continued their contretemps for all to overhear. Non-stop. A passenger in the lift asked: "I take it you two are married?" "Of course we are married" boomed the wife. "Do you think I would be living in sin with someone who plays like he does?"



The Universal Laws of Bridge

- No matter how bad your last hand was, the worst is yet to come. This law does not expire on the last hand of the match, since it has the supernatural tendency to extend well over the course of a tournament ... actually your lifetime.
- Your best game of bridge will be followed almost immediately by your worst ever. The intensity of the latter increases with the number of people you tell about the former.
- The more points or trumps you hold in your hand, the worse the distribution will be. This bridge law mocks the law of statistics. When you have an 8-card trump fit, not only will the split be (at least) 4- 1, but the opponent with the singleton will get a ruff.
- You will always forget whether a critical card has been played when it matters the most. No matter how you decide, it will always be wrong.
- No matter how well you are doing, the last three hands will automatically drop your score to what it really should be.

1NT by South shows 15-17 points. West leads the Queen of Diamonds – plan the play.
