

From the Directors

Stop Cards

Whilst stop cards themselves are gone the non-use of stop cards does not remove the requirement for a Player to wait 8 to 10 seconds before bidding if there has been a jump by his/her Right Hand opponent. The Bidder should use the 8 to 10 seconds to inquire about the bid ..(if they need to know) or just to consider their hand.

This prevents any inference from whether there is a pause or not - because there should always be a pause

Law 20. Review & explanation of Calls

Requesting an explanation - Any player is entitled to ask about a bid even if they have no intention to bid, however a player may not ask about a call if their intention is to induce a mistaken explanation or for the benefit of their partners. As the law prohibits asking for the benefit of partner a player should not ask about a call if they already know the opponent's agreement. Players also need to be aware that the content & manner of their questions may potentially create "Unauthorised Information" even when the questions themselves are legal.





Colin Carryer's Bridge Hand for Improvers: Playing Your Trumps



One of the big decisions Bridge players have is Trump management at suit play and when to lead or not to lead trumps. More hands are wrecked by the failure to lead trumps at the right time or by leading trumps at the wrong time than any other form of play. With trumps you have control of the hand (or mostly). As a general principle, except in the instances when other factors must be considered, the opponents' trumps should be drawn immediately. As always in Bridge there is never or always but this is a general principle which is good to bear in mind.

The following deal is a simple example of drawing trumps and one or two other considerations.

You are Declarer (South) playing a contract of 4 spades.

West leads the King of clubs and follows with the Ace of clubs and then follows up with a small club to the Queen - you now see the difference between no-trump play and suit play with Declarer ruffing (trumping) the third round and has control with his trumps of the club suit.

You are now on lead and have no other cards to ruff so drawing trumps becomes the priority and you play Ace and King of spades and they divide 2/2 so that is that job done. Now before you play heart winners you need to play towards the Ace, Queen, Jack of diamonds finessing the Jack when West plays low and now using the heart suit as transport back to the South hand to lead another diamond towards the Ace Queen of diamonds finessing again when West plays low and now all cards are good in the 2 hands.

Just a reasonably simple hand of playing in a suit contract, using trumps and drawing trumps at the right time and for the right reasons and doing a bit of finessing in a side suit - all common situations in many Bridge hands.
